# Bridgeland Riverside Community Association (BRCA) Annual General Meeting June 13, 2024 at 7:00 pm at the BRCA Hall

#### A. Welcome and introductions: Alex MacWilliam, President and Chair

- d) to appoint as BRCA's auditor for the 2024 fiscal period such auditor as may be engaged by BRCA through the Federation of Calgary Communities.

#### C. Presentation of Financial Statements: Jackie Fimrite, Treasurer

Jackie Fimrite presented the audited financial statements for the year ended December 31, 2023.

Jackie Fimrite highlighted various matters, and noted that the Hall closure, due to the fire, impacted revenues. She noted that other programs continued, and the financial picture is stable. BRCA paid off the CEBA loan, which generated income of \$20K.

Questions regarding insurance to cover the contents of the building, and re: the healthy surplus were asked and answered. Jackie also noted that members could view the full financials via a link to the website.
